# I. BACKGROUND

A. The United States of America ("United States"), on behalf of the Administrator of the United States Environmental Protection Agency ("EPA"), filed a complaint in this matter pursuant to Sections 106 and 107 of the Comprehensive Environmental Response, Compensation, and Liability Act of 1980, as amended ("CERCLA"), 42 U.S.C. §§ 9606 and 9607, seeking injunctive relief regarding the cleanup of the Solvents Recovery Service of New England Superfund Site in Southington, Connecticut ("Site"), and recovery of costs incurred and to be incurred in responding to the release or threat of release of hazardous substances at or in connection with the Site.

B. The State of Connecticut ("State"), on behalf of the Commissioner of the Connecticut Department of Environmental Protection, has also filed a complaint in this matter pursuant to Section 107 of CERCLA, and Conn. Gen. Stat. §§ 22a-451 seeking recovery of the response costs incurred by the State and recovery of the costs and expenses to be incurred by the State in investigating, containing, removing, monitoring or mitigating pollution and contamination at the Site.

C. The defendants that have entered into this Consent Decree (the "*De Minimis* Settling Defendants") do not admit any liability to the Plaintiffs or any matter of fact or law relating to the Site or arising out of the transactions or occurrences alleged in the complaints, nor do they acknowledge that the release or threatened release of hazardous substance(s) at or from the Site constitutes an imminent or substantial endangerment to the public health or welfare of the environment. The United States Navy (the "Settling Federal Agency") does not admit any issue of fact or law, including liability, arising out of the transactions or occurrences alleged in any counterclaim asserted by *De Minimis* Settling Defendants or any claim by the State.

D. As a result of the release or threatened release of hazardous substances, EPA has undertaken response actions at or in connection with the Site under Section 104 of CERCLA, 42 U.S.C. § 9604, and will undertake response actions in the future. In performing these response actions, EPA has incurred and will continue to incur response costs at or in connection with the Site. These response actions include, *inter alia*: (a) the removal of soils contaminated with hazardous substances; (b) the removal of drums and other containers of hazardous substances; (c) the performance of a remedial investigation at the Site; (d) oversight of response actions implemented by certain of the potentially responsible parties at the Site; and (e) various enforcement actions.

E. EPA has determined the following:

1. prompt settlement with each *De Minimis* Settling Defendant and the Settling Federal Agency is practicable and in the public interest within the meaning of Section 122(g)(1) of CERCLA, 42 U.S.C. § 9622(g)(1);

2. the payment to be made by each *De Minimis* Settling Defendant and the Settling Federal Agency under this Consent Decree involves only a minor portion of the response costs at the Site within the meaning of Section 122(g)(1) of CERCLA,  $42 \text{ U.S.C. } \S 9622(g)(1)$ .

3. the amount of hazardous substances contributed to the Site by each *De Minimis* Settling Defendant and the Settling Federal Agency and the toxic or other hazardous effects of the hazardous substances contributed to the Site by each *De Minimis* Settling Defendant and the Settling Federal Agency are minimal in comparison to other hazardous substances at the Site within the meaning of Section 122(g)(1)(A) of CERCLA, 42 U.S.C. § 9622(g)(1)(A). This is because the amount of hazardous substances contributed to the Site by each *De Minimis* Settling Defendant and the Settling Federal Agency is less than 200,000 gallons of materials containing hazardous substances, and the hazardous substances contributed by each *De Minimis* Settling Defendant and the Settling Federal Agency to the Site are not significantly more toxic or of significantly greater hazardous effect than other hazardous substances at the Site.

F. The United States, the State, *De Minimis* Settling Defendants and the Settling Federal Agency agree that settlement without further litigation and without the admission or adjudication of any issue of fact or law is the most appropriate means of resolving this action with respect to *De Minimis* Settling Defendants and the Settling Federal Agency.

THEREFORE, with the consent of the Parties to this Consent Decree, it is ORDERED, ADJUDGED, and DECREED:

## II. JURISDICTION

1. This Court has jurisdiction over the subject matter of this action pursuant to 28 U.S.C. §§ 1331, 1367 and 1345 and 42 U.S.C. § 9613(b), and also has personal jurisdiction over *De Minimis* Settling Defendants. *De Minimis* Settling Defendants and the Settling Federal Agency consent to and shall not challenge the terms of this Consent Decree or this Court's jurisdiction to enter and enforce this Consent Decree.

## III. PARTIES BOUND

2. This Consent Decree is binding upon the United States, the State and upon *De Minimis* Settling Defendants and their heirs, successors and assigns. Any change in ownership or corporate or other legal status of a *De Minimis* Settling Defendant, including but not limited to, any transfer of assets or real or personal property shall in no way alter such *De Minimis* Settling Defendant's responsibilities under this Consent Decree.

#### IV. STATEMENT OF PURPOSE

3. By entering into this Consent Decree, the mutual objectives of the Parties are:

a. to reach a final settlement among the Parties with respect to the Site pursuant to Section 122(g) of CERCLA, 42 U.S.C. § 9622(g), that allows each *De Minimis* Settling Defendant and the Settling Federal Agency to make a cash payment, including a premium, to resolve their alleged civil liability under Sections 106 and 107 of CERCLA, 42 U.S.C. §§ 9606 and 9607 and Conn. Gen. Stat. §§ 22a-432 or 22a-451, for injunctive relief with regard to the Site and for response costs incurred and to be incurred at or in connection with the Site, including obligations under the Consent Orders, thereby reducing litigation relating to the Site;

b. to simplify any remaining administrative and judicial enforcement activities concerning the Site by eliminating a substantial number of potentially responsible parties from further involvement at the Site; and

c. to obtain settlement with each *De Minimis* Settling Defendant and the Settling Federal Agency for their fair share of response costs incurred and to be incurred at or in connection with the Site by the EPA Hazardous Substance Superfund, by the State, and by other persons, and of Natural Resource Damages, and to provide for full and complete contribution protection for *De Minimis* Settling Defendants and the Settling Federal Agency with regard to the Site pursuant to Sections 113(f)(2) and 122(g)(5) of CERCLA, 42 U.S.C. §§ 9613(f)(2) and 9622(g)(5), and other applicable law.

#### V. DEFINITIONS

4. Unless otherwise expressly provided herein, terms used in this Consent Decree that are defined in CERCLA or in regulations promulgated under CERCLA shall have the meaning assigned to them in the statute or regulations. Whenever the terms listed below are used in this Consent Decree, the following definitions shall apply:

"CERCLA" shall mean the Comprehensive Environmental Response, Compensation, and Liability Act of 1980, as amended, 42 U.S.C. § 9601, *et seq*.

"CTDEP" shall mean the Connecticut Department of Environmental Protection and any successor departments, agencies or instrumentalities.

"Consent Decree" or "Decree" shall mean this Consent Decree and all appendices attached hereto. In the event of conflict between this Consent Decree and any appendix, the Consent Decree shall control.

"Consent Orders" shall mean the following orders issued in the administrative proceeding referred to as In the Matter of Solvents Recovery Service of New England, Inc. Superfund Site: (i) the Administrative Order on Consent for Removal Action, U.S. EPA Region I CERCLA Docket No. I-94-1045; and (ii) the Administrative Order on Consent for Removal Action and Remedial Investigation Feasibility Study, U.S. EPA Region I CERCLA Docket No. I-97-1000 (superceding Administrative Order on Consent for Removal Action and Remedial Investigation/Feasibility Study, U.S. EPA Region I CERCLA Docket No. I-97-1000 (superceding Administrative Order on Consent for Removal Action and Remedial Investigation/Feasibility Study, U.S. EPA Region I CERCLA Docket No. I-96-1036).

"Day" shall mean a calendar day. In computing any period of time under this Consent Decree, where the last day would fall on a Saturday, Sunday, or federal holiday, the period shall run until the close of business of the next working day.

"De Minimis Settling Defendants" shall mean those persons, corporations or other entities listed in Appendix A.

"DOI" shall mean the United States Department of the Interior and any successor departments, agencies or instrumentalities of the United States.

"EPA" shall mean the United States Environmental Protection Agency and any successor departments, agencies or instrumentalities.

"EPA Hazardous Substance Superfund" shall mean the Hazardous Substance Superfund established by the Internal Revenue Code, 26 U.S.C. § 9507.

"Interest" shall mean interest at the rate specified for interest on investments of the EPA Hazardous Substance Superfund established by 26 U.S.C. § 9507, compounded annually on October 1 of each year, in accordance with 42 U.S.C. § 9607(a). The applicable rate of interest shall be the rate in effect at the time the interest accrues. The rate of interest is subject to change on October 1 of each year.

"Natural Resources" shall mean "natural resources" as that term is defined in Section 101(16) of CERCLA, 42 U.S.C. § 9601(16).

"Natural Resource Damages" shall mean damages for injury to, destruction of, or loss of natural resources relating to the Site, including the reasonable cost of assessing such damages, as provided in Section 107(a)(4)(C) of CERCLA, 42 U.S.C. § 9607(a)(4)(C), and, for purposes of the State's claim for Natural Resource Damages, as provided in Conn. Gen. Stat. §§ 22a-6a and 22a-14 through 22a-20, inclusive.

"Paragraph" shall mean a portion of this Consent Decree identified by an Arabic numeral or an upper or lower case letter.

"Parties" shall mean the United States, the State and the *De Minimis* Settling Defendants.

"Plaintiffs" shall mean the United States and the State.

"Response costs" shall mean all costs of "response" as that term is defined by Section 101(25) of CERCLA, 42 U.S.C. § 9601(25).

"Section" shall mean a portion of this Consent Decree identified by a Roman numeral.

"Settling Federal Agency" shall mean the United States Navy.

"Site" shall mean the Solvents Recovery Service of New England Superfund Site, encompassing approximately 45 acres, located on Lazy Lane in Southington, CT, including the aerial extent of contamination resulting from operations of the former Solvents Recovery Service of New England facility, and depicted generally on the map attached at Appendix B.

"State" shall mean the State of Connecticut.

"Trust" shall mean the SRS Site 2008 *De Minimis* Settlement Trust established under the Trust Agreement.

"Trust Agreement" shall mean the Trust Agreement dated August 12, 2008 and attached as Appendix C.

"United States" shall mean the United States of America, including its departments, agencies and instrumentalities, which includes, but it not limited to, EPA, the Settling Federal Agency and any federal natural resources trustee.

#### VI. <u>PAYMENT</u>

5. Each *De Minimis* Settling Defendant shall pay to the Trust the amount specified for that *De Minimis* Settling Defendant in Appendix A within 30 days of the effective date of the Consent Decree. As provided in the Trust Agreement, \$2,234,000 of the proceeds in the Trust shall be paid to EPA to resolve claims for past and future response costs, \$2,625,000 shall be paid to CTDEP to resolve claims for past and future response costs and claims for state Natural Resource Damages, and \$200,000 shall be paid to DOI to resolve claims for federal Natural Resource Damages. The remaining proceeds in the Trust shall be paid to the potentially responsible parties performing the remedy for the Site, provided they have entered into a consent decree with EPA, or otherwise to EPA.

6. Each payment by each *De Minimis* Settling Defendant shall be made by bank check made payable to "SRS *Site 2008 De Minimis* Settlement Trust." Each check, or a letter accompanying each check, shall identify the name and address of the party making payment, and shall be sent to:

7. The total amount to be paid to EPA by the trustee of the Trust under Paragraph 5 shall be deposited by EPA in the SRS Superfund Site Special Account to be retained and used to conduct or finance response actions at or in connection with the Site, or to be transferred by EPA to the EPA Hazardous Substance Superfund.

8. As soon as reasonably practicable after the date of entry of this Consent Decree, the United States, on behalf of the Settling Federal Agency, shall pay to the Trust the sum of \$114,601. Payment shall be made as specified in Paragraph 6. If payment on

behalf of the Settling Federal Agency is not made within 120 days after the entry of this Consent Decree, Interest shall accrue on that unpaid amount from the 121<sup>st</sup> day after entry of the Consent Decree through the date of payment.

9. The Parties to this Consent Decree recognize and acknowledge that the payment obligations of the Settling Federal Agency under this Consent Decree can only be paid from appropriated funds legally available for such purpose. Nothing in this Consent Decree shall be interpreted as a commitment or requirement that the Settling Federal Agency obligate or pay funds in contravention of the Anti-Deficiency Act, 21 U.S.C. 13411, or any other applicable provision of law.

#### VII. FAILURE TO MAKE PAYMENT

10. If any *De Minimis* Settling Defendant fails to make full payment within the time required by Paragraph 5, that *De Minimis* Settling Defendant shall pay Interest on the unpaid balance. In addition, if any *De Minimis* Settling Defendant fails to make full payment as required by Paragraph 5 or Paragraph 9, the United States or the State (as appropriate) may, in addition to any other available remedies or sanctions, bring an action against that *De Minimis* Settling Defendant seeking injunctive relief to compel payment and/or seeking civil penalties under Section 122(*l*) of CERCLA, 42 U.S.C. 9622(*l*), for failure to make timely payment.

#### VIII. CERTIFICATION OF DE MINIMIS SETTLING DEFENDANT

11. By signing this Consent Decree, each *De Minimis* Settling Defendant certifies, individually, that, to the best of its knowledge and belief, it:

a. has conducted a thorough, comprehensive, good faith search for documents, and has fully and accurately disclosed to EPA, all information currently in its possession, or in the possession of its officers, directors, employees, contractors or agents, which relates in any way to the ownership, operation, or control of the Site, or to the ownership, possession, generation, treatment, transportation, storage or disposal of a hazardous substance, pollutant, or contaminant at or in connection with the Site;

b. has not altered, mutilated, discarded, destroyed or otherwise disposed of any records, documents, or other information relating to its potential liability regarding the Site after notification of potential liability or the filing of a suit against it regarding the Site; and

c. has and will comply fully with any and all EPA requests for information regarding the Site pursuant to Sections 104(e) and 122(e) of CERCLA, 42 U.S.C. §§ 9604(e) and 9622(e) and Section 3007 of the Resource Conservation and Recovery Act, 42 U.S.C. § 6927.

#### IX. COVENANT BY PLAINTIFFS

Covenant Not to Sue or Take Administrative Action Against De Minimis 12. Settling Defendants by United States. In consideration of the payments that will be made by De Minimis Settling Defendants under the terms of this Consent Decree, and except as specifically provided in Section X (Reservations of Rights by Plaintiffs), the United States covenants not to sue or take administrative action against any of the De Minimis Settling Defendants pursuant to Sections 106 or 107 of CERCLA, 42 U.S.C. §§ 9606 or 9607, and Section 7003 of the Resource Conservation and Recovery Act, 42 U.S.C. § 6973, relating to the Site, including Natural Resource Damages and all obligations under the Consent Orders. With respect to present and future liability, this covenant not to sue shall take effect for each De Minimis Settling Defendant upon the Trustee's receipt of that De Minimis Settling Defendant's payment under Paragraph 5. With respect to each De Minimis Settling Defendant, individually, this covenant not to sue is conditioned upon: (a) the satisfactory performance by De Minimis Settling Defendant of all obligations under this Consent Decree; and (b) the veracity of the information provided to EPA by De Minimis Settling Defendant relating to De Minimis Settling Defendant's involvement with the Site. This covenant not to sue extends only to De Minimis Settling Defendants and does not extend to any other person.

13. <u>Covenant for Settling Federal Agency</u>. In consideration of the payment that will be made by the Settling Federal Agency under the terms of this Consent Decree, and except as specifically provided in Section X (Reservation of Rights by Plaintiffs), the United States hereby covenants not to take administrative action against the Settling Federal Agency pursuant to Sections 106 or 107 of CERCLA, 42 U.S.C. §§ 9606 or 9607, and Section 7003 of the Resource Conservation and Recovery Act, 42 U.S.C. § 6973, relating to the Site, including Natural Resource Damages and all obligations under the Consent Orders. This covenant not to take administrative action shall take effect upon receipt by the Trustee of the Settling Federal Agency's payments under Paragraph 8. This covenant not to take administrative action is conditioned upon the satisfactory performance by the Settling Federal Agency of its obligations under this Consent Decree. This covenant extends only to the Settling Federal Agency and does not extend to any other person.

14. <u>State Covenant Not to Sue or Take Administrative Action Against</u> <u>De Minimis Settling Defendants and Settling Federal Agency</u>. In consideration of the payments that will be made by *De Minimis* Settling Defendants and the Settling Federal Agency under the terms of this Consent Decree, and except as specifically provided in Section X (Reservations of Rights by Plaintiffs), the State covenants not to sue or take administrative action against any of the *De Minimis* Settling Defendants or the Settling Federal Agency pursuant to Sections 107 of CERCLA, 42 U.S.C. § 9607 and Conn. Gen Stat. §§ 22a-432, 22a-451, 22a-6a and 22a-14 through 22a-20, inclusive, relating to the Site, including Natural Resource Damages. This covenant not to sue shall take effect for each *De Minimis* Settling Defendant and the Settling Federal Agency upon receipt by the trustee of the Trust of that *De Minimis* Settling Defendant's and the Settling Federal Agency's payment under Paragraph 5 or 8. With respect to each *De Minimis* Settling Defendant, individually, and to the Settling Federal Agency, this covenant not to sue is conditioned upon: (a) the satisfactory performance by *De Minimis* Settling Defendant or Settling Federal Agency of all obligations under this Consent Decree; and (b) the veracity of the information provided to EPA by *De Minimis* Settling Defendant or the Settling Federal Agency relating to *De Minimis* Settling Defendant's or the Settling Federal Agency's involvement with the Site. This covenant not to sue extends only to *De Minimis* Settling Defendants and the Settling Federal Agency and does not extend to any other person.

#### X. RESERVATIONS OF RIGHTS BY THE PLAINTIFFS

15. The United States and the State reserve, and this Consent Decree is without prejudice to, all rights against *De Minimis* Settling Defendants and the Settling Federal Agency with respect to all matters not expressly included within the Covenant by Plaintiffs in Paragraphs 12, 13 and 14. Notwithstanding any other provision of this Consent Decree, the United States and the State reserve all rights against *De Minimis* Settling Defendants and the Settling Federal Agency with respect to:

a. liability for failure to meet a requirement of this Consent Decree;

b. criminal liability; or

c. liability based upon the ownership or operation of the Site, or upon the transportation, treatment, storage, or disposal, or the arrangement for the transportation, treatment, storage, or disposal, of a hazardous substance or a solid waste at or in connection with the Site, after signature of this Consent Decree by *De Minimis* Settling Defendants or the Settling Federal Agency.

16. Notwithstanding any other provision in this Consent Decree, the United States and the State reserve, and this Consent Decree is without prejudice to, the right to institute proceedings against any individual *De Minimis* Settling Defendant or the Settling Federal Agency in this action or in a new action or to issue an administrative order to any individual *De Minimis* Settling Defendant or the Settling Federal Agency seeking to compel that *De Minimis* Settling Defendant or the Settling Federal Agency to perform response actions relating to the Site, and/or to reimburse the United States and/or the State for additional costs of response, if information is discovered which indicates that such *De Minimis* Settling Defendant or the Settling Federal Agency contributed hazardous substances to the Site in such greater amount or of such greater toxic or other hazardous effects that such *De Minimis* Settling Defendant or the Site because *De Minimis* Settling Defendant or the Settling Federal Agency and be materials containing hazardous substances to the Site, or contributed hazardous

substances which are significantly more toxic or are of significantly greater hazardous effect than other hazardous substances at the Site.

# XI. COVENANT NOT TO SUE BY DE MINIMIS SETTLING DEFENDANTS

17. *De Minimis* Settling Defendants covenant not to sue and agree not to assert any claims or causes of action against the United States or the State or their respective contractors or employees with respect to the Site or this Consent Decree, including, but not limited to:

a. any direct or indirect claim for reimbursement from the EPA Hazardous Substance Superfund based on Sections 106(b)(2), 107, 111, 112, or 113 of CERCLA, 42 U.S.C. §§ 9606(b)(2), 9607, 9611, 9612, or 9613, or any other provision of law;

b. any claims arising out of response actions at or in connection with the Site, including any claim under the United States Constitution, the Constitution of the State of Connecticut, the Tucker Act, 28 U.S.C. § 1491, the Equal Access to Justice Act, 28 U.S.C. § 2412, as amended, or at common law;

c. any claim against the United States pursuant to Sections 107 and 113 of CERCLA, 42 U.S.C. §§ 9607 and 9613, relating to the Site; and

d. any claims against the State pursuant to Sections 107 and 113 of CERCLA, 42 U.S.C. §§ 9607 and 9613 or Conn. Gen. Stat. 22a-452, relating to the Site.

18. Except as provided in Paragraph 21 (Waiver of Claims) and Paragraph 23 (Waiver of Claim-Splitting Defenses), these covenants not to sue shall not apply in the event the United States or the State brings a cause of action or issues an order pursuant to the reservations set forth in Paragraph 15(c) or Paragraph 16, but only to the extent that *De Minimis* Settling Defendants' claims arise from the same response action, response costs, or damages that the United States or the State is seeking pursuant to the applicable reservation.

19. <u>Covenant by Settling Federal Agency</u>. Settling Federal Agency hereby agrees not to assert any direct or indirect claim for reimbursement from the Hazardous Substances Superfund (established pursuant to the Internal Revenue Code, 26 U.S.C. § 9507) through CERCLA Sections 106(b), 107, 111, 112, 113, or any other provision of law with respect to the Site or this Consent Decree. This covenant does not preclude demand for reimbursement from the Superfund of costs incurred by the Settling Federal Agency in the performance of its duties (other than pursuant to this Consent Decree) or as lead or support agency under the National Contingency Plan (40 C.F.R. Part 300). 20. Nothing in this Consent Decree shall be deemed to constitute approval or preauthorization of a claim within the meaning of Section 111 of CERCLA, 42 U.S.C. § 9611, or 40 C.F.R. 300.700(d).

21. <u>Waiver of Claims</u>. Each of the *De Minimis* Settling Defendants agrees not to assert any claims or causes of action (including, but not limited to, claims or causes of action under Sections 107(a)(4)(B) and 113(f) of CERCLA) that they may have for all matters relating to the Site against each other or any other person who is a potentially responsible party under CERCLA at the Site. This waiver shall not apply with respect to any defense, claim, or cause of action that a *De Minimis* Settling Defendant may have against any person if such person asserts or has asserted a claim or cause of action relating to the Site against such *De Minimis* Settling Defendant. This waiver also shall not apply to any claim for indemnification or reimbursement from a Party's insurance carrier or other contractual indemnitor.

# XII. EFFECT OF SETTLEMENT/CONTRIBUTION PROTECTION

22. Except as provided in Paragraph 21 (Waiver of Claims), nothing in this Consent Decree shall be construed to create any rights in, or grant any cause of action to, any person not a Party to this Consent Decree. Except as provided in Paragraph 21 (Waiver of Claims), the United States, the State and *De Minimis* Settling Defendants each reserve any and all rights, defenses, claims, demands, and causes of action which each Party may have with respect to any matter, transaction, or occurrence relating in any way to the Site against any person not a Party hereto.

23. <u>Waiver of Claim-Splitting Defenses</u>. In any subsequent administrative or judicial proceeding initiated by the United States or the State for injunctive relief, recovery of response costs, or other relief relating to the Site, *De Minimis* Settling Defendants shall not assert, and may not maintain, any defense or claim based upon the principles of waiver, *res judicata*, collateral estoppel, issue preclusion, claim-splitting, or other defenses based upon any contention that the claims raised in the subsequent proceeding were or should have been brought in the instant action; provided, however, that nothing in this Paragraph affects the enforceability of the covenant not to sue included in Paragraphs 12 and 14.

24. The Parties agree, and by entering this Consent Decree this Court finds, that each *De Minimis* Settling Defendant and the Settling Federal Agency are entitled, as of the effective date of this Consent Decree, to protection from actions or claims as provided by Sections 113(f)(2) and 122(g)(5) of CERCLA, 42 U.S.C. §§ 9613(f)(2) and 9622(g)(5), for "matters addressed" in this Consent Decree, or other applicable law. In addition, the Parties agree, and by entering this Consent Decree this Court finds, that each *De Minimis* Settling Defendant and the Settling Federal Agency are entitled to contribution protection with respect to any claims that otherwise might be asserted against them under Connecticut law. The "matters addressed" in this Consent Decree are (a) all response actions taken or to be taken and all response costs incurred or to be incurred, at or in connection with the Site, by the United States, the State or any other person, and (b) Natural Resource Damages.

#### XIII. <u>RETENTION OF JURISDICTION</u>

25. This Court shall retain jurisdiction over this matter for the purpose of interpreting and enforcing the terms of this Consent Decree.

#### XIV. INTEGRATION/APPENDICES

26. This Consent Decree and its appendices constitute the final, complete and exclusive agreement and understanding among the Parties with respect to the settlement embodied in this Consent Decree. The Parties acknowledge that there are no representations, agreements or understandings relating to the settlement other than those expressly contained in this Consent Decree. The following appendices are attached and incorporated into this Consent Decree:

"Appendix A" is the list of *De Minimis* Settling Defendants and the payment schedule.

"Appendix B" is the map of the Site.

"Appendix C" is a copy of the Trust Agreement.

#### XV. <u>PUBLIC COMMENT</u>

27. This Consent Decree shall be lodged with the Court for a period of not less than 30 days for public notice and comment. The United States shall file with the Court any written comments received and the United States' response thereto. The United States reserves the right to withdraw or withhold its consent if comments regarding the Consent Decree disclose facts or considerations which indicate that this Consent Decree is inappropriate, improper or inadequate. The State may withdraw or withhold its consent to the entry of this Consent Decree if comments received disclose facts or considerations which show that the Consent Decree violates state law. The United States reserves the right to challenge in court the withdrawal by the State from the Consent Decree, including the right to argue that the requirements of state law have been waived, pre-empted or otherwise rendered inapplicable by federal law. The State reserves the right to oppose the United States' position taken in opposition to any proposed withdrawal. In addition, in the event of the United States' withdrawal from this Consent Decree, the State reserves its right to withdraw from this Consent Decree. De Minimis Settling Defendants consent to entry of this Consent Decree without further notice, and the United States and the State reserve the right to oppose an attempt by any person to intervene in this civil action.

### XVI. EFFECTIVE DATE

28. The effective date of this Consent Decree shall be the date of entry by this Court, or a motion to enter the Consent Decree is granted, whichever occurs first, as recorded on the Court's docket.

#### XVII. SIGNATORIES/SERVICE

29. Each undersigned representative of a *De Minimis* Settling Defendant to this Consent Decree, the Assistant Attorney General for the Environment and Natural Resources Division of the United States Department of Justice, or his delegatee, and the Assistant Attorney General for the State certifies that he or she is fully authorized to enter into the terms and conditions of this Consent Decree and to execute and bind legally such party to this document.

30. Each *De Minimis* Settling Defendant hereby agrees not to oppose entry of this Consent Decree by this Court or to challenge any provision of this Consent Decree, unless the United States has notified *De Minimis* Settling Defendants in writing that it no longer supports entry of the Consent Decree.

31. Each *De Minimis* Settling Defendant that is a member of the SRS PRP Group hereby designates Robert Kirsch, Wilmer Cutler Pickering Hale & Dorr LLP, 60 State Street, Boston, MA 02109, as the agent who is authorized to accept notices by mail and by email on behalf of that Party with respect to all matters arising under or relating to this Consent Decree. Each *De Minimis* Settling Defendant that is not a member of the SRS PRP Group hereby identifies, on its signature page, the name and address of an agent who is authorized to accept notices by mail and by email on behalf of that Party with respect to all matters arising under or relating to this Consent Decree. *De Minimis* Settling Defendants hereby agree to accept service including, but not limited to, service of a summons, in that manner and to waive the formal service requirements set forth in Rule 4 of the Federal Rules of Civil Procedure and any applicable local rules of this Court. The Parties agree that *De Minimis* Settling Defendants need not file an answer to the complaint in this action unless or until the Court expressly declines to enter this Consent Decree.






